The Compensation Committee approved an award of restricted stock units (RSUs) pursuant to the 2015 Omnibus Incentive Compensation Plan. The RSUs vest 33% annually (1) beginning on April 1, 2017 and for each of the following two years concluding on April 1, 2019. Upon vesting, the RSUs convert into shares of Class A Common Stock on a one-for-one basis.

(2) Withholding of stock to satisfy statutory tax withholding obligations on vesting of restricted stock.

The Compensation Committee approved an award of non-qualified stock options pursuant to the 2015 Omnibus Incentive Compensation Plan. The options vest 33% annually

(3) beginning on April 1, 2017 and for each of the following two years concluding on April 1, 2019.
